Drains and Lanes

There have been drainage issues for many years on Loudwater Lane, but with continual prompting from LRA and co-operation from Herts County Council (HCC) / Ringway over the last 3 years, the regular gully clearing has eradicated the flooding we had become used to. This has demonstrated that the infrastructure can cope when it is clear. Ringway made some minor drainage improvements in March and the gullies were cleared in early May, with this visit being the 11th in the last 3 years. The majority of the drains network is required to be cleared once every 18 months by way of comparison. HCC have now added Loudwater Lane to their vulnerable gully list which are cleared more frequently and may provide additional signing to make drivers aware of the potential risk of flooding. As ever, if a resident notices that drains are becoming blocked or the road has flooded please bring it to the attention of the LRA so action can be taken.

Options such as kerbing and expanding water run-off areas have been considered to alleviate the flooding, but these proposals are not currently funded, and it is also debatable how effective they might be.

The verge erosion during rainfall carries high volumes of silt into the gullies along with leaves in autumn and much of the road surface debris as it continues to decay along significant stretches of Sarratt Lane and

Loudwater Lane. This has also been a problem for a number of years with relentless pothole repairs, and the only "ray of light" being the resurfacing of Parrots Dell on Loudwater Lane a couple of years ago following much lobbying of HCC. Unfortunately, the condition of the lanes is now so bad in places that they have fallen beyond Ringways mandate to maintain and with nothing in the future HCC highways plans they had effectively been left to fall into disrepair.

However, in May, with support from Chris Hayward, the LRA have managed to persuade the HCC Cabinet Member responsible for highways to drive the lanes and his experiences have resulted in major works being integrated into the HCC Traffic Regulation Order (TRO) in the next couple of years. The lanes will be audited by the end of May, with the intention they be re-surfaced full length in

2017/2018 and the TRO has been amended to incorporate all sections of Loudwater Lane, meaning that Ringway have the potential to carry out any urgent repairs later this year. In addition Saratt Lane is incorporated for surface dressing preparation in 2017, and for dressing in 2018, and is also now incorporated in the amended TRO so that Ringway can programme repairs at the same time as the planned work for Loudwater Lane in winter 2016.

So, please continue to log potholes on the HCC website (http://www.hertsdirect.org/) and I'll be watching this very closely in the coming months reporting in more detail as and when information becomes available.

Bonfires

You hate them or love them. It is a topic which gets raised on many occasions.

Although many people assume that there are specific bye-laws to prohibit bonfires, there are none within the Three Rivers District.

However, if a neighbour is causing a nuisance by burning rubbish, the law is on your side. Under the Environmental Protection Act 1990, a statutory nuisance includes "smoke, fumes or gases emitted from premises so as to be prejudicial to health or a nuisance". In practice, to be considered a nuisance, a bonfire would have to be a regular problem and interfering substantially with your well-being, comfort or enjoyment of your property.

You can be reported to the council if your bonfire becomes a nuisance on a regular basis. This is a type of antisocial behaviour. To make a report, a log should be kept of dates when the problem occurred.

If you have a problem with a neighbour's bonfire, talk to them first. If that doesn't work, you can register a complaint by contacting the Customer Service Centre by telephone (01923 776611) or e-mail enquiries@threerivers.gov.uk. Always give an indication of when you can be found at home, or where you can be contacted during the day. Try to give a precise location of the source of the problem.

Also I do not believe there any covenants within the private roads that cover bonfires either.

One of the largest complaints is with residents who employ gardeners who have bonfires and then leave them smouldering for days or burst

back into life unattended. Drifting smoke on a fine summer's day can be very annoying.

Additionally within Loudwater we have a number of thatched houses and stray sparks from an unattended bonfire creates significant risk for those houses with a thatch.

With Three Rivers Council deciding to charge more for brown bin collection this could encourage residents to have more bonfires. My recommendation is to compost garden waste or take it to the tip.

So please make special effort to reduce bonfires, make sure that the smoke is not drifting onto neighbours and bonfires should not left unattended.

Just a little common sense and consideration for neighbours goes a long way towards a safe and happy community
