


The food was amazing and it was great to see everyone again, and also to meet new residents who have volunteered their time to help Loudwater.

On the 22nd April, former Ol' Trout editor and Chairman of the Loudwater Estate Board Robert Kenison, ran what has since been officially recorded as the hottest ever London Marathon. In temperatures which peaked at just

over 24 degrees centigrade, he completed the 26.2 miles in an incredible 4 hours and 7 minutes. Robert admitted that it was tough going, but was understandably delighted to have made it.

He was running to raise money for a great charity that is close to his family's hearts – Phab Kids. Phab inspires and supports children, young people and adults with and without disabilities to make more of life together - breaking down community barriers, reducing social isolation, and creating opportunities for disabled people to enjoy the same activities and challenges as, and alongside, those without a disability.

Robert shared that, over the last 10 years his son Tom and daughter Alexandra have been supporting Phab Kids. They attend weekend and week Phab club activity holidays as volunteers. Alex and Robert ran the Marathon together.

Roberts' fundraising and sporting endeavours continue. On 29th July he will be tackling Prudential Ride London, a 100 mile cycle, with his older brother – once again raising money for Phab Kids.

Remembering Gary Coster


Sadly, earlier this year Loudwater lost a much loved resident, Gary Coster. Here his wife Buzz, pays tribute to him.

Giving people and furniture a second chance

9 Lives Furniture is a Rickmansworth based charity which exists to put unwanted furniture to good use, to prevent re-useable materials going to waste and help thousands of people create a safe home environment.

9 Lives will collect locally free of charge from donators, and deliver from their showroom in Wharf Lane, Rickmansworth, WD3 1HA.

Their showroom is open to the public selling furniture, pictures, books, kitchenware, vintage items and objects of interest at the lowest price possible. There is also a referral system in place that enables customers on means tested benefits to receive a 50% discount.

9 Lives also provides vocational training to people who specifically (but not exclusively) are recovering from mental ill health or who have a learning disability. These courses are provided free. Students can enjoy converting a piece of unwanted furniture into something special for resale in the shop. Techniques taught include how to strip, wax, polish or paint furniture. Restoring furniture can be very therapeutic; it helps build self-esteem, confidence and improve social skills working within a small friendly environment.

One student on completion said 'I have really learnt a lot on this course, and have met some lovely people. I have got some of my confidence back.

Japanese Knotweed

Planning Secretary Mike Sindic, once again shares his knowledge with us – this time in relation to the dreaded plant life, Japanese Knotweed.

A county court judge recently gave a judgment in what is thought to be the first agreed claim for damages arising from the existence of Japanese Knotweed on a neighbour's land.

Although it is not a binding decision it could open the floodgates for a large number of other claims, particularly if it is challenged in the higher courts and upheld.

Japanese Knotweed (JKW) is a bamboo-like plant that is very strong and grows incredibly quickly. It can spread underground through its roots. As it grows, JKW can cause damage to drains, paths and walls. Many mortgage lenders will not agree to lend against a property that is located within seven metres of JKW. This makes it very difficult for existing owners to sell their property.

The Wildlife and Countryside Act 1981 makes planting it a criminal offence. The Environmental Protection Act 1990 and the subsequent Environmental Protection Act (Duty of Care) Regulations 1991 categorise JKW as 'controlled waste' and specify that a licence is required to deal with, treat, and dispose of it. Failure to obtain such a licence is an offence. As such, the removal of JKW should be undertaken by a licensed person or agency. Inevitably, this tends to be expensive.

In Williams & Waistell v Network Rail Infrastructure Ltd (2nd February 2017) two adjoining bungalow owners brought claims against Network Rail for allowing JKR roots and shoots on their land to spread under their bungalows. The actions were heard jointly, and

they claimed an injunction requiring the removal/treatment of the JKW and damages. Their claims were based on private nuisance i.e. unreasonable interference with their land.

The bungalows are in Maesteg in South Wales. No 1 cost £49,500 in 2003 and No 2 cost £65,000 in 2012. The bungalows are at the top of an embankment leading down to the railway line below. Network Rail own the land up to their boundaries.

The JKW has been present on the embankment for at least 50 years but the complaint was not actually made until 2013. However, Network Rail were aware some years before of the danger posed to the bungalows by the JKW on the embankment.



Japanese Knotweed can cause physical damage to property and so any claim for damages is likely to include:

- Cost of removing the JKW or an order requiring the defendant to remove it.
- Cost of any remedial works to the claimant's property.
- Compensation for reduction in property value due to the existence of JKW making it difficult to sell.

In relation to damages in most nuisance claims, the claimant must have suffered some actual physical damage or an unreasonable interference with their property rights, which has caused the loss of enjoyment of their property or proprietary interest. The judge's decision in *Waistell* introduces the possibility that a claim can be pursued even where no actual damage has been sustained.

The judge held that a claim based on an encroachment by the roots was not actionable unless actual damage had been caused. This re-affirmed the principle that a claimant needs to actually suffer some damage for a claim to be actionable. However, the judge did maintain that the JKW interfered with Waistell's property as he could not sell it for full market value, therefore a claim for nuisance was justifiable. The judge explained that the nuisance could be nearby and did not require an actual encroachment from Network Rail's land onto Waistell's land.

The Court concluded that damages was the appropriate remedy. The Court awarded each claimant £10,000 to offset reduction in property value and £4,320 for treating the JKW on their land. It also awarded £350 per year as general damages for loss of amenity. However, it should be noted that the case lasted three days in Court and involved detailed evidence from JKW experts and property valuers. Also, lawyers acted for both sides, so the legal costs must have been many times the damages awarded. However, similar awards on a pro rata basis in respect of more expensive properties could lead to substantially higher awards.

I will report on this further if indeed an appeal is lodged.
